RENTAL TERMS AND CONDITIONS

USE - the customer shall use the Equipment in a clean, safe manner. It shall be maintained in the manner contemplated for its use.

LOSS OR DAMAGE - the customer shall use the Equipment at their own risk and shall indemnify and save *fast fence inc.*, harmless from and against any and all liability, loss, damage, expense, causes of action, suits, claims or judgements from injury to persons or property or death arising from or in connection with the actual or alleged use, operation, delivery or transportation of the Equipment.

It is agreed that the Equipment is rented from *fast fence inc*. by the renter for their own use and will not be loaned, sub-let, mortgaged or in any other manner disposed of by the renter. The renter will be responsible for any loss or damage to the Equipment except for ordinary wear and tear.

The owner makes no warranty of any kind on the Equipment. The renter agrees to use the Equipment entirely at their own risk. Continuing maintenance is the responsibility of the renter.

Once installation is complete, and the customer has signed for the Equipment, the Equipment, and its' maintenance, is the responsibility of the customer.

Upon completion of rental and notice by customer to **fast fence inc.**, that the Equipment is to be picked up; the customer is responsible for the Equipment for a period not to exceed 7 days in the event that **fast fence inc.** is unable, for whatever reason, to pick up the Equipment immediately. When the renter has picked up material from **fast fence inc.**, the material is on rent and under the responsibility of the renter until it has been returned to **fast fence inc.**

INSTALLATION DIRECTION - On site direction by your personnel is required. **Relocations** after installation are at the expense of the customer.

RENTALS ARE PAYABLE IN ADVANCE - all rental charges, delivery, installation, deinstallation, pickup charges are payable in advance. Invoices are due for payment 30 days after issuance. Failure to pay invoices as due may result in the Equipment being picked up. This is at the sole option of **fast fence inc**. Failure to provide site security is the responsibility of the customer.

fast fence inc. is not required to serve notice of such action.

Credit Card, Driver's License and other personal information is collected for the sole use of **fast fence inc.** will not disclose your personal information to third parties unless we are required or permitted by law to do so.

All delinquent accounts are subject to 2% interest per month. The debtor shall be responsible for all costs to redeem a delinquent account, including collection, court and legal fees.

SECURITY DEPOSITS - are required at the discretion of *fast fence inc*.

THE RENTER IS RESPONSIBLE FOR ALL DAMAGES TO THE EQUIPMENT, REGARDLESS OF CAUSE.

Acceptance of the Equipment constitutes acceptance of these terms.
